Town and Country | Planning Act 1990 Appeal Under Section 78

Melcourt Industries Ltd - Extension to yard used for the storage of horticultural products It was resolved to issue the previous comment made by Crudwell Parish Council. Crudwell Parish Council objects to this application as a highways issue. The visibility splay around the yard is not suitable for the goods vehicles, nor are the rural roads which will be used to access and egress the site. We are particularly concerned of the danger at school drop off and pick up times when we know these roads will be busy as routes to and from local schools.

CPC/23/122 Wiltshire Council report

Wiltshire Council remains better placed than many other councils with a relatively low overspend of £1.38 Million. Many councils continue to suffer from contract inflation costs. Requirements for housing land supply moves from 5 to 4 years. Some relaxation in delivery of additional housing to small villages providing the look and feel of the village is maintained.

CPC/23/123 Neighbourhood plan report

The Neighbourhood Plan Steering Group met formally on Monday the 10th July 2023.

RL reported that Sian Burke-Murphy who had been responsible for initiating the 2021 Crudwell Neighbourhood Plan had now resigned from the NP Steering Group.

Tristan Stevens, also, had requested that he step back from his role as Vice Chairman and Cllr. Stephen Butcher was duly elected as Vice Chairman. Tristan will continue to be an active member of the Steering Group.

RL thanked Tristan for his work in helping to complete the 2021 plan and suggested that the PC may wish to express it's gratitude to Sian for her vital part in the 2021 Neighbourhood Plan.

The report highlighted the salient points of the draft Wiltshire Local Plan which is now available for consultation. The plan seta out a strategic housing requirement for Crudwell of 39 new dwellings between 2022 and 2038 with a residual requirement of 11 dwellings when existing commitments (including Tuners Lane) are discounted.

Following the conclusion of the NP Review consultation a detailed report and discussion document was prepared from Vision Planning

The NP Steering Group met to go through the report and to determine a work plan to take forward the work required to develop the Reg 14 consultation.

The plan comprises three main areas of work as follows:

- Design and development, led by Cllr. Roy Lambley assisted by Cllr. Gary Lawes will include housing allocation and design guide review.
- Business Development, led by Cllr. Olly Hughes assisted by Helena Everson-Goddard
- Community and Leisure, led by Cllr. Steve Butcher.

7 Rillis 2023 15 AUG 2023 The NP Review remains on target for Reg 14 in the Autumn 2023 and Referendum Summer 2024 and within allocated budget.

Community Liaison Group, (CLG) Tuners Lane Development

There. Is no further update from the Tuners Lane site agents but a planning application is expected soon. The CLG issues with the design of the dwellings continue to be unresolved.

Swillbrook water level has increased and possible strimming and clearing of the stream is deferred to August meeting.

The trees surveyors have been contacted by the Clerk and will attend in early August to complete a conditions survey of trees in the parish council ownership.
