- 4. Please note that nomination papers MUST be received within the statutory timescales stated and **hand delivered only** or they will not be accepted. Nomination papers received through the post or by electronic means will NOT be accepted and will be deemed as not received in the prescribed manner.
- 5. If the election is contested the poll will take place on Thursday 22nd June 2017.
- Applications for postal and postal proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday 7th June 2017.
- 7. Amendments or cancellations to existing postal, postal proxy and proxy votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Wednesday, 7th June 2017.
- 8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5 pm on Wednesday 14th June 2017.
- 9. A person can apply to vote by 'emergency' proxy if they learn they cannot go to the polling station because of their occupation, service or employment, or a medical condition, illness or disability arises after 5pm on Wednesda 14th June 2017. The application must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5pm on Thursday, 22nd June 2017.
